IMPORTANT DATES & REGISTRATION INFORMATION

Dual enrollment students with an appointment will be able to register for fall classes beginning the week of April 19th. This is two weeks prior to Open Registration. As always, students must have a completed Dual Enrollment Registration Form (DERF) to complete the registration process. EFSC advisers will not register a student whose form is missing a signature or is otherwise incomplete. ****Reminder: West Shore is offering Dual Enrollment for Periods 5-7 only. Please choose your classes accordingly (afternoon/evening or online so they don't conflict with your morning classes at school)!**** Below are key dates:

- **4/19/21 thru 8/5/21:** Dual Enrollment students can email their West Shore School Guidance Counselor to initiate the Dual Enrollment Registration Form (DERF). Please choose the classes you intend to take before emailing your counselor (see link below for how to view EFSC course catalog).
- **Monday, 4/19/21:** The registration window for the Fall term opens for Dual Enrollment students who have scheduled an appointment for online/web registration. DE students without an advising appointment may NOT register between 4/19-5/3. Only students with appointments will be permitted to register during this time.
 - To schedule an appointment, students should log into the myEFSC Student Services Portal, by looking for the blue heading that says Student Services Appointments and using the info in that area to make the advising appointment. It is important that students select a date for their appointment that falls within the college-designated registration window (must be on or after 4/19/21).
- **Monday, 5/3/21:** Open Registration Begins. ***Important Note: EFSC Advisors are offering virtual help, plus in-person sessions by appointment only to assist students who normally drop in for registration assistance, including dual enrolled students. See the advising section of the EFSC website for more details. Students eligible to register online should do so.**
- **Friday, 7/30/21:** Last day to complete Dual Enrollment Registration Form (DERF) with West Shore School Guidance Counselor. Students who do not complete the DERF by this date risk not being able to register on time with EFSC.
- **Thursday, 8/5/21:** Last day to Register with EFSC for Spring 2021 classes. Again, students must have a completed Dual Enrollment Registration Form (DERF) to complete the registration process. EFSC advisers will not register a student whose form is missing a signature or is otherwise incomplete.
 - Once students successfully register for classes, they must bring a hardcopy of their schedule (printed from their Titan account) to the Guidance Office and the Media Center so that we can schedule their classes in the system and order their course materials. **Students who fail to bring their schedule in a timely manner may not receive their textbooks in time for classes.**
- **Monday, 8/16/21:** Fall Classes Begin
