Dress Code Policy po5511

- The dress code shall include requirements for the appropriateness of clothing, clothing accessories, and footwear, which will maintain adequate standards of safety, health, and welfare for all students.
- O The standards of appearance for students shall ensure that the student be clean, neat, and properly dressed.
- O Students shall observe modes of dress and standards of personal grooming which are in conformity with the studious atmosphere and good personal hygiene necessary in schools.

Dress Code Violations

- O Students who violate the dress code are to be sent to the Dean's office for discipline consequences.
- O Students are not permitted to wear clothing which contains printed profanity, gang paraphernalia, sexual, vulgar, drug, alcohol, or tobacco-related wording/graphics or may tend to provoke violence or disruption in school shall not be worn.
- All clothing must be appropriately sized, securely fastened and cover midriff, back, sides, and all undergarments at all times. For example, suspenders should be over the shoulders, pants secured at the waist, belts buckled, no underwear as outerwear, no underwear exposed.
- No see-through garments, strapless garments, tube tops and halter tops are not permitted.

Dress Code Violations

- O Pants and shorts shall conform to the build and stature of the student, shall be worn at the waist, and shall not extend below the heel of the shoe in length.
- Rips, holes, or tears in clothing must be below midthigh.
- O Shorts must have clearly discernable inseams that covers the buttocks.
- O Roller skates, skate shoes, and slippers are not allowed.
- O Spikes, or sharp objects, wallet chains, and heavy link chains are not allowed.
- O Dress shall not emulate non-human characteristics.
- O Students must remove hats, shades, and hoods when inside.

ID Badges

- O It is mandatory for ALL students at Stone Magnet Middle School to wear or be in possession of their Student ID badge at all times (and have it visible) appropriately on campus and on the buses.
- O Student ID badges are utilized for teachers and staff to easily identify any student on campus.
- O Students must have an ID badge to ride the bus, purchase breakfast/lunch, field/courts, classroom attendance, issue tardy passes, hall passes, library, and PBIS points/rewards.

Cell Phones

Headphone, Ear-buds, Speakers

- Cell phones are to be off and away during the school day except at breakfast and lunch. Phones are to be stored in a bag or pocket, not in your hands or on your desk. Phones may only be used during breakfast and lunch.
- O Student who have their phones out and using them, will receive discipline consequences and the phone will be confiscated. All confiscated phones are turned in to the Dean's office.
- O 2nd infraction will result in the loss of cell phone privileges.
- Ear-buds or headphones are not to be worn around the student's neck once the school day has begun. Items will be confiscated.
- O Speakers are not permitted on campus, they will be confiscated.

Attendance

- Attendance shall be required of all students enrolled in the schools during the days and hours that the school is in session.
- School attendance shall be the responsibility of parents/guardians and students.
- Students who miss more than five (5) days of school during each nine-week period will be submitted to the district truant officer.

Tardy to Class

- O The expectation is that you are on time to every class. You have 4 minutes to get to your class.
- O If you are tardy to class you're marked tardy on the attendance.
- Your 3rd tardy will result in having 1 week of lunch detentions, and an additional week for each 3rd tardy that follows.
- After the 6th tardy you will receive discipline referrals and extended consequences.

Bully/Harassment po 5517.01

- The School Board is committed to providing an educational setting and workplace that is safe, secure, and free from bullying and harassment for all students and employees.
- The Superintendent shall develop a comprehensive plan intended to prevent bullying and harassment and to cultivate the school climate so as to appropriately identify, report, investigate, and respond to situations of bullying and harassment as they may occur on school grounds, at school-sponsored events, and through school computer networks.

Bully/Harassment po 5517.01 con't

- "Bullying" includes "cyberbullying" and means systematically and chronically inflicting physical hurt or psychological distress on one (1) or more students or employees. It is defined as any unwanted and repeated written, verbal, or physical behavior, including any threatening, insulting, or dehumanizing gesture, by an adult or student, that is severe or pervasive enough to create an intimidating, hostile, or offensive educational environment; cause discomfort or humiliation; or unreasonably interfere with the individual's school performance or participation;
- "Harassment" means any threatening, insulting, or dehumanizing gesture, use of data or computer software, or written, verbal or physical conduct directed against a student or school employee that:

What to do about Bullying and Harassment?

- O Tell the offender to stop.
- Walk away.
- Seek help from a trusted adult.
- Report immediately!
- If you have a conflict with a student come to the Dean's office to report.
 - Peer mediation will be used to resolve the issue.

No-Go List

- A list of students that have not abided by the school rules or policies for reasons unknown.
- O If you receive 3 behavioral referrals you are on the No-Go-List. If you fight you are automatically on the list.
- O If you have over-due library books you are on the No-Go-List.
- O If you owe any fees you are on the NoGo-List.

What if your name is on the No-Go List?

- O If your name is placed on the No-Go list you cannot attend school functions.
- O No in-school events such as: School Dance, Block Party, Student/Faculty Events, etc.
- No Spring Fling, No GradVenture (8th graders only),
 No Sea World (7th graders only)
- O Possibility of not attending school field trips sponsored by clubs, coaches, or teachers

Lunch

- O There are 3 lunches (A, B, C) and students are escorted to lunch.
- O Where can I sit during my lunchtime?
 - Cafeteria
 - Outside on patio
- ALL food and drink is permitted inside the cafeteria and at the tables on the patio. Trash is placed in the garbage.
- You must eat your lunch before you can go to the field to play or to the library. No food on the field and no food in the library.

Lunch Procedures

- O Students are escorted to lunch.
- O Students **must be seated** during lunch, no running or horseplay.
- You are not allowed to bring outside food to the cafeteria to eat such as McDonalds, Subway, Burger King, Lizzy's, etc.
 - O If outside food is brought in you will not be able to eat in the cafeteria; you will be escorted to the guidance office.
 - No walking around campus: cafeteria, patio, media center, or field are the only areas you are allowed during lunch.
- O No DoorDash, Uber- Eats, Grubhub ect., discipline consequences will be given.

Clinic

- O Stone maintains a school clinic for emergency illness and accidents only!
- O Bandages will be given ONLY to students WHO ARE INJURED AT SCHOOL. IN ORDER TO BE SEEN BY THE CLINIC NURSE, ALL STUDENTS MUST HAVE A HEALTH CARE CONSENT FORM ON FILE.
- O You must have a pass from your teacher to go to the clinic.

Fire and Critical Incident Drills

- Each month we will conduct a fire drill and a critical incident drill.
- O You will not be informed when the drill will occur.
- O Drills may occur at any time of the day.
- The purpose of this procedure is to ensure that there are procedures in place to protect students, staff and school property in the event of an active threat, severe weather, and/or active assailant.

Safety

- O If the fire alarm goes off wait for someone to come on the intercom and verify which evacuation plan will be used.
- O Do not move if no one comes on the intercom or if they say a different evacuation plan!!! If that happens "Go in Lock-down Mode"
- O SAFETY FIRST!!

Positive Behavioral Interventions and Supports

- O We are a PBIS school, we want to give credit to the achievements and positive behavior our students exhibit.
- We would like to give our students an opportunity to receive positive recognition for their efforts in displaying appropriate behavior.
- O You are able to earn a positive behavior points for displaying appropriate behavior and academic achievement.
