<p>Driving is a privilege. There are specific driving rules which must be obeyed when operating a golf cart on the Viera High School campus. Please review the driving rules on the reverse side of this form. The student and his/her parent must sign this contract before driving privileges are awarded to the student. Failure to comply with the contract rules will result in loss of student driving privileges. NO REFUNDS will be issued for revocation or suspension of driving privilege. These procedures are in place to ensure the safety to students, parents, staff and visitors at Viera High School. Improper operation of a golf cart can result in injuries to students and others. Please drive safely on and off campus.</p>

Driving Rules on Campus

1. Operate your golf cart in a safe manner consistent with all of the state of Florida traffic laws.
2. Park only in the designated student parking for golf carts.
- 3. Display your parking sticker on front panel on driver seat side.**
4. Leaving campus in your golf cart, once school is in session, without permission could result in revocation of your parking privilege.
5. This permit is for parking in the grass area in front of the stadium ticket booth. Students are NOT PERMITTED TO PARK IN THE BACK FACULTY OR SCHOOL BOARD/ESF PARKING LOTS.
6. Viera High School maintains the right to search all golf carts parked in our school parking lot upon reasonable suspicion.
7. If you arrive late to school, you must check in at the Attendance Office. Multiple tardiness will result in your driving privileges being suspended.
8. Parking tags issued to students are not transferrable to other students. Lost tags should be reported immediately.
9. Failure to follow parking rules can result in disciplinary action and /or revoking of parking permit.
- 10. AT NO TIME DURING SCHOOL HOURS (8:00AM – 4:00PM) WILL STUDENTS BE ALLOWED TO DRIVE GOLF CARTS IN THE CAR PARKING LOT IN THE FRONT OF THE SCHOOL.**
11. Drivers and passengers must remain seated while cart is in motion. They must also keep arms and legs inside the cart. You must never allow anyone to sit on the drivers or passengers lap while cart is in motion. Passengers are also limited to the number of seats in the cart and must be seated in the position intended
12. Golf cart operator must be at least 14 years old.
13. Golf cart must comply with all Brevard County Regulations
