To remove these barriers, we will take into consideration the topics in which families have shown interest in through multiple surveys. Ample notification of events will be sent out in multiple forms of media to ensure all families are aware of time and location. Translation of notifications will also be sent out in Spanish, Haitian Creole, and other languages upon request.

Letters are sent home with every student that has been taught for four or more consecutive weeks by a teacher who is out of field. A copy of the letter and a list of the parents who receive the letter is kept on file as documentation for auditing purposes.

Teachers and staff who are fluent in other languages are readily available to assist our non-English speaking families throughout the school day and during parent conferences. ESOL teachers participate in parent conferences as needed and are available to translate during parent involvement activities. Material is disseminated in English, Spanish, and Haitian Creole as needed.

Special accommodations are made during IEP meetings, phone conferences, and Zoom meetings are available upon request. Workshops offered by the district are advertised in Weekly School Newsletter.
